Any person who owns or harbors any dog, cat or other domestic animal, whether licensed or unlicensed, which bites any person, shall forthwith confine and quarantine the animal for a period of fourteen days for rabies observation. If such animal is not so confined and quarantined, the humane officer, dog warden or sheriff may cause such animal to be placed in custody and are of a licensed veterinarian for such purposes at the owners expense. The penalty for any violation of this section shall be a fine of fifty dollars or confinement in the county jail for a period of no less than two or more than three days.
