Mr. John W. Hatcher, Attorney appeared before the Commission . RE: Substitution of Committee -- Linda Sue Rider. On this day 4th day of January, 1984, came John W. Hatcher, Jr. and Anna J. Rider, and presented to the Commission the following facts:

- a. That she is the natural mother of Linda Sue Rider, a 31 year old incompetent person;
- b. That on November 13, 1973, Lonnie Rider was appointed, in Fayette County, as Committee for the aforenamed incompetent person;
- c. That Lonnie Rider was the natural father of said incompetent person and the husband of Anna J. Rider:
- d. That Linda Sue Rider, aforenamed, suffered sever head and brain injuries in 1956 as a result of an auto accident.
- e. That the aforenamed daughter has been, since the accident, unable to manage her business affairs:
- f. That the aforenamed daughter's source of income is a 143.00 per month Social Security check, in addition to some interest from some government bonds she owns;
- g. That the aforenamed daughter lives with aforenamed mother;
- h. That Lonnie Rider, aforenamed, died on December 2, 1983;
- i. That Anna J. Rider desires to be substituted as Committee for her aforenamed daughter.

The Commission after due consideration of the aforementioned facts, is of the opinion that Anna J. Rider should be named and appointed Committee for Linda Sue Rider, an incompetent, in lieu of Lonnie Rider deceased.

It is therefore, the Order of this Commission that Anna J. Rider be and she is hereby appointed as Committee for Linda Sue Rider, an incompetent, and that said Committee post a surety company bond of \$10,000.00 to insure her faithful performance of her fiduciary duties as said Committee.

Carl Harris is hereby awarded a fee of to be paid from the estate os Mary Eugenia Kennedy. George Vickers designated as Commissioner of Accounts.

Petitioner therefore moves that a Guardian Ad Litem be appointed to represent her interests herein. By Phillip J. Tissue.

On this 7th day of March, 1984, at a regular meeting of said Commission, consideration was given to the appointment of a new Commissioner of the Salem-Gatewood Public Service District to serve in the place of Loren, J. Fox, whose resignation has been heretofore tendered and accepted, and after giving due consideration to the same it is hereby ordered that Mr. Joe Idleman, whose name has been recommended, be appointed to fill the unexpired term of Mr. Loren J. Fox, said term expiring September 1, 1984.

Appearing before the Commission came Michael Anderson, Attorney; RE: Committee appointment for Rodney Pennington, Convict. RE: THE APPOINTMENT OF CAROLYN S. PENNINGTON AS COMMITTEE FOR RODNEY K. PENNINGTON.

PETITION: Your Petitioner, Carolyn S. Pennington respectfully represents as follows:

- (1) That she is 36 years of age and resides at 105 Lavendar Street, Oak Hill, Fayette County, West Virginia. She is the wife of Rodney K. Pennington.
- (2) That her husband, Rodney K. Pennington is a person confined in the penitentiary of this State under sentence for one (1) year or more and that your petitioner is proceeding, pursuant to Chapter 28, Article 5, Section 33 of the Official Code of West Virginia as amended.
- (3) That the estate of Rodney K. From the testimony of all the parties, including the statement of the Guardian ad litem, the Court finds as follows:

- 1. That the respondent is unable to manage her business affairs in that she has no ability to know and appreciate the nature and effect of her business transactions, and that she is a resident of the Care In Nursing Home in Ripley, West Virginia.
  - 2. The respondent is unable to care for her physical well-being.
  - 3. That the respondent is therefore incompetent.

The Commission hereby appoints as Committee for the respondent, Richard Norford, her son, with all the powers and duties conferred upon him as a Committee under the applicable laws of the State of West Virginia.

It is further ADJUDGED and ORDERED = that the Committee shall post bond with recognized corporate surety in the amount of Five Thousand Dollars (\$5,000.00), said bond to be given upon the condition that Richard Burford will well and truly account for all money and properties that come into his hands by virtue of such appointment, and will well and truly preserve the value of the estate of the respondent to the best of his ability, and it is ORDERED that the County Clerk shall refer this Committeeship to a Commissioner of Accounts according to the laws regarding such appointment of Commissioners of Account. George Vickers is designated as Commissioner of Accounts.

The Commission received bids for a 4-wheel drive vehicle for use at the Fayette County Park. King Coal Chevrolet of Oak Hill, West Virginia, submitted the only bid which was received, and the Commission awarded the bid to King Coal Chevrolet.

The Commission received a request from Frank McKown, New Haven Executive Committeeman, that through the recommendation of the Board of Precinct 67 at Lookout the polling place be moved from Nuttall Middle School to the Nuttall Middle School Gymnasium in order to eliminate the large number of steps that lead up to the Middle School. The Commission took this request under consideration.

Gary Harding appeared before the Commission and presented the following request: : Jack Clark, Owner, for a change in land classification

from B-2, General Business District, to B-3, Highway Business District on Lots 18,19,21,22,24 & 25 Home Seekers Truck Farms, off Route 38, Summerlee Road, near Corridor "L", Plateau District. The County Commission was informed by the Zoning Officer that the Planning Commission did by a vote of 9-0 recommend that this request be approved for the location of a kennel for the Humane Society. Mrs. Bea Burgess, Vice-President of the Fayette County Emergency
Food Coalition, presented a report from that organization to the Commission
regarding the expenditures of grant monies totaling \$30,000.00 which

the Commission had previously awarded to the Food Coalition. Mrs. Burgess made another request of the Commission to allocate funds in the amount of \$10,500.00 per month to supplement the food coalition program. The Commission approved an amount totaling \$10,500.00 for the fiscal year ending June 30, 1984, to be granted to the Fayette County Food Coalition from Coal Severance Tax monies. Lopez, the County Commission of Fayette County, West Virginia, does hereby approve and authorize the adoption of the resolution authorizing Charles M. Vickers to execute, to have acknowledged, and to have delivered on behalf of the County, an application with the State of West Virginia for Community Development Block Grant Funds.

Mr. Fred Jesser, Attorney for the Town of Fayetteville, appeared before the Commission to voice the town's objection to the selection

of the Akers's building as the site for the magistrates' office in Fayetteville. Mr. David Akers was also present to hear this objection. No action was taken.

#### ARTICLE II. DEFINITIONS

<u>Kennel.</u> Any establishment including cages, dog runs and structures wherein more than five dogs which are over six months old are harbored.

ARTICLE XIV. EXCEPTIONS AND SPECIAL PROVISIONS

Section 1400. Uses permitted as special exceptions.

# Subsections 1, 2, 3, & 4

After public notice and hearing and under conditions set forth below, the Board of Zoning Appeals may authorize the issuance of a special permit for any of the following buildings and uses:

ADD: Kennel provided that no structure for the confinement, care or breeding of dogs shall be located at a distance of less than one hundred (100) feet from any property line, and futher provided that any kennel approved in accordance with the conditions sit out below adhere to United States Humane Society Guidelines dated April 1982.

Conditions: Such special permits, however, may be authorized by the Board of Appeals only upon satisfaction in each instance of such conditions as to the general character, height and use of structure or structures; as to the provision of surrounding open space and the treatment of the grounds; as to the general fitness of the structure or use to its proposed location; as to the provisions for automobile parking or storage; and as to street capacity and use as, in the opinion of the board, may be necessary to safeguard public health, comfort and convenience, and as may be required for the prevention of the general character of the neighborhood in which such building is to be placed or such use is to be conducted.

Mr. Gordon Billheimer, presented a letter of notice that Mr. Eugene Hogan and Mrs. Margaret McKnight are going to contest the election of the Board of Education ballot vote. Mr. Billheimer enclosed a notice stating that Mr. Norman R. "Whitey" Harlan and Mr. Carroll E. Bumgarner would be served with notice. Mr. Billheimer requested that the County Commission set a date for the hearing of this matter. The Fayette County Commission set a hearing date for Monday, June 18,1984 at 1 P. M.

The Petitioners seek to void said election in its entirety, because the Circuit Clerk of Fayette County prepared invalid ballots by violating the West Virginia Code, Chapter 3, Article 5, Section 6, which provides "each candidate seeking the office shall be identified as to the magisterial district from which he is a resident". The official ballots used in the election described above did not designate the magisterial district in which the candidate resided.

The Code section cited above further provides that only two members shall be elected from the same district and "if more persons from a magisterial district receive the highest number of votes in said election, then of such persons only, the person or persons having the highest vote who do not make the aggregate number of elected members and holdover members more than two from such magisterial district, shall be described elected, and the remaining members shall be declared from the highest from other magisterial districts...".

One incumbant member of the Board of Education was from Plateau District and thus only one candidate from Plateau District could be elected.

Because the magisterial district of each candidate was not designated on the ballot, the voters in many cases voted for Carroll Bumgarner and Margaret McKnight who were both from Plateau District. This is shown by the number of votes cast to-wit: Carroll E. Bumgarner, 7,276; Margaret McKnight

6,975; with Norman Harlan receiving 4,449. Thus, the voters were effectively disenfranchised. Thus, Norman Harlan received the most votes from the candidates from districts other than Plateau.

The Petitioners further contend that the ballot for the Fayette County Board of Education members should have had an explanation of Code Section 3-5-6 cited above to explain to the voters that only one of the candidates could be elected from Plateau District.

There being no further business to come before the Commission, the meeting was adjourned.

Jones informed the commission by letter that the community of Minden had been given approximately 2 acres of land by the Berwind Land Company, for a playground project for the children. The community committee members- Carol Jones, Ioma Watts, Christine Lynch, Joretta Thompson, and Sam Calloway stated that they hoped the Commission would fulfill their special request. The Commission approved Richard Bragg to purchase up to \$2,000.00 with playground equipment for site located at old Minden School pursuant to request. Mr. Bragg also is to see the Board of Education and Vo-Tech Center concerning backloader.

The Commission received a letter that was received from the West Virginia Department of Human Services (Welfare) concerning a Resource Unit to help supply needy Fayette County residents with some of the necessities of life they are being deprived of due to the economic situation in our county. The unit stated that it was a non-profit organization and solely dependent on donations. Connie Dempsey, Chairman of the Resource Unit stated that the churches and civic groups had been very generous to the unit. The Moose Lodge in Oak Hill has funded a prescription program which is administered through the unit. The Unit is working with the American Legion Post, in Fayetteville, to fund a dental program to be administered through the unit. The food that is given from the pantry is given in an emergency situation only. The food is given to last a period of three days. These are one time service situations. A needy person does not have to be a recipient of public assistance to qualify for the service of this project. They need only be: (1) a resident of Fayette County (2) they must show a true need (3) Have no other available resources to meet their need. The income guidelines that are used to determine the eligibility are the same as for the Emergency Assistance Program. They are as follows: 1 Person Household \$334.00 2 Person Household \$458.00 3 Person Household \$566.00 4 Person Household \$711.00 5 Person Household \$819.00. All the donations received are audited by the auditors from the state office and would be open to the Commission anytime they would wish to conduct an audit. The Resource Unit requested \$20,000.00 from the Fayette County Commission to help keep the program going. The Commission asked if separate entity incorporated. The Commission stated that this may not be a proper expenditure. The Commission is to check with auditor of State Tax Department.

Mr. Guy Waugh, representing the Veterans of Foreign War, requested a \$5,000.00 donation for construction of monument. The Commission requested the legality of expenditure. The Commission stated it would check into this.

The Commission took action on the letter received from the Town of Gauley Bridge. This letter was requesting the release of the remainder of the fifty thousand dollars (\$50,000.00) which the commission allocated the town in 1981. This money to be used for a much needed recreation facility for the Valley Area of Fayette County as well as for the people on the border of Nicholas and Clay Counties. The Commission stated that it must have intergovernment agreement for voucher and have resolution authorizing such agreement and expenditure.

On the 13th day of July, 1984, at a regular meeting of said Commission consideration was given to the appointment of a new commissioner of the New Haven Public Service District to serve in the place of Larry Harrah who has resigned, said resignation having been tendered and accepted and after giving due consideration to the same it is hereby ordered that Frank Hill, whose name has been recommended, be appointed to fill the unexpired term of Larry Harrah said term to expire October 29, 1984.

The Commission filled a vacancy that was expired on the Fayette County Board of Health, On the 13th day of July, 1984, it was brought to the attention of the Fayette County Commission that the term of Robert Stephens of Charlton Heights, West Virginia, on the Fayette County Board of Health expired on June 30, 1984 and it appearing further that the Fayette County Baord of Health has recommended that he be reappointed, it is hereby ordered that Robert Stephens be appointed for a five (5) year term to be effective July 1, 1984, said term expiring June 30,1989.

Mr. Edward O. Coleman appeared before the Commission requesting to be sworn in for the Peepwater Public Service District. The Commission approved the appointment of Mr. Edward O. Coleman. On the 13th day of July, 1984, at a regular meeting of said Commission consideration was given to the appointment of a new Commissioner of the Peepwater Public Service District to serve in the place of Larry Joe Bragg, whose resignation has been heretofore tendered

and accepted. After giving due consideration to the same, it is hereby ordered that Mr. Edward O. Coleman, whose name has been recommended by the Board of Deepwater Public Service Distirct, be appointed to fill the unexpired term of Mr. Larry Joe Bragg, said term to expire March 1, 1985.

The Fayette County Commission approved \$20,000 for the fiscal year 1984-85, to the Office of Behavioral Health Services, West Virginia Department of Health, for the establishment, operation and maintenance of a local mental health program," as required by section 27-8-2 and 27-8-2a of the West Virginia Code (1965,c,99,1966,c.43;1977,c.102).

A letter was sent from the Commission to Mr. Timothy T. Laraway, P. E. Supervisior, Solid Waste Division, West Virginia Department of Natural Resources. This letter advised that effective June 15,1984 ordered that all dumping be terminated at the Fayette County #2 Landfill located near Ansted, W. Va. All citizens and county haulers formerly using the facility have been notified to take all garbage to the Fayette County #1 Landfill located near Cunard W. Va.

President of the Commission Mr. Charles M. Vickers, being duly authorized to make affidavit for the County Commission of Fayette County: and further depose and say that Valley Medical Service, Inc., Drawer 358 Alloy, West Virginia 25002-0358 is either a bona fida volunteer fire department, non profit ambulance service or emergency rescue service within the County of Fayette. This was taken, sworn and subscribed on the 13th day of July, 1984.

The Fayette County Fireman's Association appeared before the Commission. Mr. Steve Cruikshanks, and Mr. Mike Rutledge representing the association told and ask about distributing the excess levy funds that were not allocated in the past three years. The association stated that they had established guidelines for the spending of excess levy funds that were not allocated during the past three years. Mr. Rutledge stated that a financial statement had been sent to agency and should have response soon. Mr. Rutledge and Mr. Cruikshanks also talked about the idea of a County Fire Co-Ordinator, and stated they would present a proposal in the near future. They also noted that the departments must present a written request and that the request must be approved by the association officers before money would be distributed. They stated several departments have had letters approved and are in need of the funds. They therefore requested the county to disburse these funds to the fire departments that have been certified by the association and having met all requirements. The Commission ask if the spending of money would be in line with levy auidelines.

The Commission also received a letter from the Danese Volunteer Fire Department and Rescue Squad, Inc. They noted that one of their newest ambulances was involved in an accident on February 6, 1984, and that there was extensive damage to this unit which has not yet been repaired. The estimate we obtained from the local Ford garage was \$954.25. This did not include 1 running board and 2 new tires replaced on the right side of this unit. The department noted that the ambulance is in use daily and while there is no mechanical defects due to this damage, it has become increasingly apparent that the condition of the body is rapidly deteriorating from the damage already sustained. The letter also noted that the department wished to ask if the Commission was going to pay and be responsible for these repairs. The department also stated that at this time the department is not financially able to pay for these repairs, as their funding has been cut. They also stated that all of the fund raising events have been quite disappointing. The Danese department noted that they would greatly appreciate any assistance from you on this matter as the unit is the main stay of the operation. The Commission approved for repair bills be sent to Fayette County Commission. It was also noted that running board would cost \$200.00 and \$104.94 each for tires. Copy of insurance form and estimate was enclosed also.

Mr. Lopez ask to talk to the Commission on the behalf of Mr. Joe Craffy from Kanawha Falls, concerning the painting of tank. Mr. Lopez noted that he understood that \$36,500 was needed. The Commission stated to stand by the original committment of \$21,500.

Mr. Vickers stated that Ann Covington, on behalf of the Fayetteville High School Band, ask if they could use the courthouse lawn for a yard sale. The Commission said this has not been allowed before, and therefore should stand the same. The Commission said they could use the parking lot, or any graveleled or Memorial Building lot or area that the County has.

Mr. Rozell stated that they wanted to see if the County might want the property for county purpose before offering it to the public. Mr. Vickers and Mr. Bragg stated that they knew of no use for the county. They suggested that Mr. Rozell contact the Danese Fire Depratment and see if they might be interested.

Appearing before the Commission was Mr. T. E. Myles, representing the Mossy Public Service District. Mr. Myles wanted the Commission to help out the Mossy Public Service District, as they are in dire need. Mr. Myles stated that they would need in the range of \$65,000, and they want the Fayette County Commission to contribut half and try to get the other half from the Governor's Office. Mr. Myles stated that this was a one million and a quarter water works. Mr. Myles stated the condition of the system was absolutely terrible.

Ms. Sue Sowder of Wingrove appeared before the Commission stating that she has a problem with flooding where she lives, and she wonders who might help her in the situation. She was referred to the Department of Natural Resources.

Mr. Lee Massey and Mr. Tim Laraway, who represents the Department of Natural Resources, Solid Waste Supervisor, told the Commission that they had not ordered for Landfill # 2 to be closed. Mr. Laraway stated that now applications would be sent out and would be clarified in writing. They stated that the lease for #2 Landfill would be continued.

Mr. Wayne Inge, representing Mr. Don Taylor, for hearing of Armstrong Public Service District. Mr. Inge stated that he was informed by Mr. Steve Vickers that the meeting was cancelled. The representative for the Armstrong Public Service District informed the Commission that Mr. Vickers had told them he would no longer represent them, so they ask for a new hearing date as they would be retaining Mr. Pat Hamilton as a lawyer. Mr. Inge and Mr. Hamilton are to get together and set a new date, to be schelduled with the Fayette County Commission.

The resolution for the White Oak Public Service District that was already in the budget was presented to the Fayette County Commission as follows:

RE: APPROVAL Of GRANT FUNDS for the WHITE OAK PUBLIC SERVICE DISTRICT SCARBRO, WEST VIRGINIA

WHEREAS: Members of the Board of Commissioners of the White Oak Public Service District did appear before the Fayette County Commission to request grant funds for essential repairs and improvements to the White Oak Public Service District water system:

WHEREAS: The Fayette County Commissin did investigate the physical condition of the said water system and duly found that repairs were essential for the continued operation of said system:

WHEREAS: The Fayette County Commission did include within the 1984-85 levy estimate a sum in the amount of \$18,500.00 for such repairs: Now therefore be it hereby resolved that;

a grant in the amount of \$18,500.00 be approved for the White Oak Public Service District, and be it further resolved that as a condition for the granting of said funds, the Commissioners of the White Oak Public Service District shall abide by county purchasing practice and procedures as prescribed by the West Virginia Code.

A letter was sent to the West Virginia Department of Human Services from the Commissioners stating they had completed the review for their request for funding for the Resource Unit established by the Fayette County office of the West Virginia Department of Human Services for fiscal year 1984-85. The Commission told the department that due to the increased obligations and responsibilities of the County, funding for the Resource Unit could not be approved.

The Commission approved contingently \$2,850.00 to the Bellwood Community Facilities Improvement Corporation up to the state bid.

The Commission also sent a letter to Fayette County Food Coalition-Beatirce R. Burgess, Vice-President, to state that they had reviewed their request for additional funding for the Food Coalition for fiscal year 1984-85. The Commission stated that they had decided that a final appropriation of \$13,500.00 would be made available to the Coalition. Mr. Luther Boyd appeared before the Commission about the Landfill funding for Montgomery. Mr. Boyd stated that they would need \$50,000.00 and would like the Commission to contribute \$25,000.00. Mr. Boyd stated that they hoped to get the remaining \$25,000.00 from the Kanawha County Commission. Mr. Boyd stated if refused by the Kanawha County Commission that they would try to raise the money. Mr. Boyd stated that the Landfill is run by the City of Montgomery. The Commission informed Mr. Boyd that they would consider and inform as soon as possible.

A representative from IBM appeared before the Commission presenting information about a computor set up for the Commission. Mr. Michael Manley representing IBM told the Commission about the advantages of the IBM computor and the size of computor that would be suitable for what they needed it for. He also told them some of the prices for the extra software and hardware. The Fayette County Commission met in regular session on October 15, 1984.

The Commission received a letter from David W. Knight Prosecuting Attorney of Mercer County in Re: State vs Brown, Dempsey and Pennington - to the attention of Charles Vickers. In response to a telephone conversation, Mr. Knight made the following proposal in the above cases. Mr. Knight would handle cases in their entirety for a maximum fee of \$4,050.00 based on the following:

- 1. \$1,500.00 for all investigative and pre-trial matters in each and every case, some of which has already been preformed and for any further work.
- 2. \$300.00 for the Grand Jury to be conducted on November 13, 1984.
  - 3. \$750.00 for pre-trial conducted.

These figures submitted include mileage and any other expenses which Mr. Knight has personally but does not include the necessity of his purchasing transcripts and he would expect the County Commission to pay those type of expenses.

Mr. Knight noted under this proposal if the Grand Jury on November 13, 1984 did not indict the defendants the total bill owed to Mr. Knight would be \$1,800.00.

If the Grand Jury indicts the defendants you would have a grand total bill of \$1,800.00, plus \$750.00 for each trial regardless of its length, so that if he tried all 3 cases the maximum for the trials would be \$2,250.00, making a total outlay by the County Commission of \$4,050.00.

The Commission decided to pay the \$1,500.00 for all pre-trial matters now and then pay the \$300.00 following the Grand Jury and the \$750.00 following each trial. This was accepted by the Commission pursuant to October 15, 1984.

The Commission received a letter from the City of Mount Hope, from Jonas A. Davis, Mayor. Mr. Davis stated that since Mt. Hope has a Voluntary Fire Department, which receives money from the County Levy, for this purpose Mr. Davis wants to know if they aren't suppose to have an Audit of their accounts annually or ever so often to advise the City Council as to how they are using their money. Mr. Davis stated he felt they were due an accounting of their transactions once a year. He stated the firemen act as though it is none of their business.

The Commission received a letter from the Co-operative Extension Service. This letter stated that it had approved an out of state trip for Bob Arthur. This was to notify the Commission of the upcoming expenditure of funds previously appropriated by the Fayette County Commission.

The Commission received a letter from Robert K. Holliday stating that John Moses who lives in the White Oak Public Service District has expressed a real interest in getting fire hydrants located with in the Public Service Commission jurisdiction. Mr. Moses stated the location of these hydrants should be placed every 1,000 feet. This would improve greatly the aid of fire fighting and insurance rates would be lower.

The Commission received a letter from the W. Va. State Tax Department. This was to inform of the State Tax Department's intent to begin the reappraisal field work in the county the week of October 8, 1984.

The Commission received a letter from Jack Manning, Sheriff, stating the resignation of Jackie Thompson Robinson who resigned October 5, 1984 from the Tax Office.

A letter was received from Home Insurance Company, due to complaint made by John Kevin England.

A letter was received from the Women's Resource Center. This letter was received asking for funding.

A preliminary evaluation for the new prosecuting attorney's office was discussed and presented to the Commission from Donald H. Stark of Beckley. This was in reference to the new Magistrate Building and the Prosecutors Office.

An administrative order from Supreme Court of Appeals

of West Virginia was received from the Circuit Clerk. RE: Assignment of the Honorable John H. Frazier To The Twelfth Judical Circuit .

Payroll and all bills presented were approved.

There being no further business to come before the Commission  $\tilde{l}$  the meeting was adjourned.

The Fayette County Commission met in regular session on the 31st day of October. Appearing before the Commission was T. E. Myles, Attorney, for the appointment of Emmette Spade for Ethel Spade. Emmette Spade and his attorney, T. E. Myles presented to the Commission and ask leave to file the petition of Emmette Spade wherein he seeks to be appointed Committee for his wife, Ethel Spade. Counsel for the petitioner further presented to the Commission and asked leave to file the affidavit of Dr. George L. Fischer and copies of certified mail receipts indicating that a copy of the petition herein and notice of this hearing has been duly served upon the children of Ethel Spade, they being her nearest next of kin.

The Commission examined the said petition, the aforementioned affidavit and the return receipts and a copy of the notice duly mailed to the nearest next of kin of Ethel Spade, and it is ORDERED by the Commission that said documents be and they are hereby ordered filed.

The Commission doth find that Ethel Spade is 73 years of age; that she is suffering from dementia; that she is totally out of touch with reality, and is wholly incapable of managing her financial affairs or caring for her personal needs; that she cannot count money or dress or undress herself, and acts as a person would act at the age of two years.

It appearing to the Commission proper so to do, it is ORDERED that

Emmette Spade shall be and he is hereby appointed Committee for Ethel Spade;

Mr. Spade shall designate to the Commission three appraisers to appraise the Estate of Ethel Spade and he shall post bond in the penalty of \$10,000.00 with surety to be approved and take the necessary oath. Noel Fox, Robert Surface, and Charles Brown of Meadow selected to appraise the estate and Thelma Richmond as surety on said bond.

Phil Tissue, Attorney appeared for David L. and Phylis Miller, for closure of Alley, Deed Book \$ 410 at Page 22. The applicant desires to fence said alley way making their two lots into one large one. The applicants state the alley way has not been used for over twenty years, and no one will be adversely affected thereby. Wherefore the applicants request the following action of the County Commission: 1- That it close and vacate the alleyway which is referred to herein by order entered of record; 2- For such other and further relief as the facts and circumstances of case may warrant.

Gary Harding appeared before the Commission for Cecil H. and Martha J. O'Dell and Billy Aliff. This was tabled indefinite because of opposition.

Butch Joyce from Solid Waste Resources made presentation before the Commission on the proposed plan of landfill sites for transfer station.

Mr. Joyce presented three plans and alternatives. The Commission is to start looking for sites for possible location of three transfer points.

The Commission o'ked the acquisition of IBM computor system. This will be accepted if can get approval from State Tax Department if approval of accounting system from State Tax Department.

Mr. Bragg and Mr. Gannon noted the Landfill at Cunard will have new open and close hours beginning November 19, 1984. The hours will be 8 A. M. to 5 P. M. .

Pursuant to request from Armstrong Public Service District, for Homer Lundy to be appointed to replace Don Taylor. The Commission approved this move. Mr. John Lopez made the motion and Mr. Jim Lively seconded the motion.

Order for the approval of check for Food Coalition was approved to be paid.

There being no further business and all bills presented were approved and payroll approved, the meeting was adjourned.

The Commission proceeded then to go to visit the new shelter built by the Fayette Humane Society.

The Fayette County Commission met in regular session on November 7, 1984. The Commission heard a representative from Goodwin & Goodwin, about change in Federal Law of low mortgage homes. New law requires County to put in a local paper, to publish compliance report or past present of bond. The new law requires one local paper to publish prior to January 1, 1985. The County Commission will not incur the cost, the bonding company of Goodwin & Goodwin will pick up cost.

Mr. T. E. Myles appeared before the Commission with Mr. George W. Tolley, seeking to be appointed committee for Olive Hinkle. Mr. Tolley is the son-in-law of Olive Hinkle. Mr. Tolley and his wife who is the daughter of Olive Hinkle, took oath before the Commission stating that this was for the purpose of getting help for Ms. Hinkle, who is in a nursing home in Rainelle. The children of Olive Hinkle had been notified. This was approved by the Commission and bond was set and filed with the County Clerk on September 7, 1984.

The Commission approved to pay election workers for the polls and schools  $\dot{}$ . This is not to exceed \$99.99.

Gary Harding presented a map to the Commission and a report on land, for closure of a alleyway, from the October 31, 1984 meeting, for David and Phylis Miller. Mr. J. C. Prather, Box 159, Page noted concern about fire hydrant. Therefore the Commission did not approve the closure of this alleyway.

The canvas of the election will be held Wednesday, November 14, 1984, beginning at 8:30 A. M.

There being no further business to come before the Commission and all bill approved the meeting was adjourned.

Mr. Gary Harding from Zoning Commission appeared before the Commission. The following cases were presented to the County Commission for a disposition.

Z-276-84-1: Request of Sammy Joe Fragale, Owner, by James Blankenship, Attorney for a change in land classification from RR-1, Agricultural and Rural Residence District, to I-1, Light Industrial District, on .45 acre, White Oak (J. M. Ellis Estate Property), Greentown, Plateau District.

Z-277-84-1: Request of Raymond E. Gravely, Owner, for a change in land classification from RR-1, Agricultural and Rural Residence District, to B-2, General Business District on part of .96 acre, near Court House, located at Fayette Heights, New Haven District.

The applicant was not present on either case and the Zoning Officer informed the County Commission that by a vote of 7-0 recommend that the request be denied. These were for a welding shop and a used car lot.

The Fayette County Commission received bids for county property and casualty insurance coverage. Mountain State Insurance Agency, Inc of Montgomery presented the only proposal.

There being no further business to come before the Commission the meeting was adjourned. Payroll and bills presented were approved.

The Fayette County Commission met in regular session on November 28, 1984. Mr. John H. Lopez made a motion and Mr. Vickers said that as President of the Fayette County Commission that the county will approve guarantee agreement for purchase of fire trucks on condition that capital outlay would take preference over the fire levy expenditures. Mr. Vickers stated the agreement would be signed. The motion was unanimously approved. Mike Rutledge appeared on behalf of the Fayette Firemens Association.

Mayor Fred Neudek on behalf of the Mayor's Association contacted Mr. Vickers and asked the County Commission to take no action on the fire co-ordinator hiring, until the Mayor's Association could review the co-ordinators resume. Mr. Vickers informed Mayor Neudek that the firemen's association had requested the position and the Fayette County Commission would not take any further action until a request was placed before the Commission.

The Commission approved two layoffs of 2 employees of the Fayette County Landfill due to shorter hours and inclement weather, effective January 1, 1985 if necessary.

The Commission approved matching funds application for Life Line Ambulance.

Mr. Lopez notified the Fayette County Commission of his resignation from FMRB Board of Directors. Richard Bragg notified Commission that two vacanies existed on FMRS for Fayette County. The Commission appointed James Keenan and Jean Carte.

Appearing before the Commission from Exit Conference 1983-84 Audit from Trainer-Wright Associates on behalf of audit was the following present: C. M. Vickers, John H. Lopez, Howard E. Janney, Richard W. Bragg, Jack Manning, Ann Berry.

The Commission approved the purchase of 16 Goodyear Tire at stated bid price - plus installation.

The Commission approved continuation of snow removal with Jack Gannon as in previous years.

The Commission dp proved payment of EEO and personnel seminars for Mr. Bragg.

Mr. Bragg presented the bid for roofing of jail from Beckley Roofing Company in the amount of \$7,760.00. The Commission accepted the bid and the project is to be monitored.

The audit report was presented and the Commission accepted the invoice on the audit. Mr. Vickers ask that the audit be accepted and the vote was 3-0 in favor.

A letter was received by the Commission from the Twelfth Judical Circuit of West Virginia, J. Zane Summerfield, Judge, in reference to the Magistrate Office Building. The Commission made note that the letter was received. The Commission requested that they receive estimate and plan for discussion at a later date.

Mr. Bragg ask if possible to purchase certain equipment for shop. Affirmative o'k by Mr. Vickers. This is not exceed \$2.000.00.

The Courthouse will close on December 24th and 25th for Christmas Holiday as this goes along with state offices. The Courthouse will also close on December 31 and January 1, 1985 as also state holidays.

A dinner will be held by the lawyers of the Bar Association for the workers of the courthouse on December 21, 1984. The scheldule of the time to go will be worked out among the workers themselves.

The County Commission made motion to put Shirley Love on the Correctional Officer Civil Service Board.

Payroll was approved and all bills paid to the end of the year.

The Commission will meet on January 9, 1985 for the first meeting of the year.

John H. Lopez will preside as President of the Commission.

appearing before the Commission and stated to Mr. Jackson that they would get
back in touch with him. The Commission informed Mr. Bragg to check into the legality
of the We Care Program for contribution.

Mr. Paige Skaggs from the Committee on Aging appeared before the Commission and stated that he agreed and approved of the bid from Lou Morgan builders. Mr. Skaggs stated that if the money was not used by July 1, 1985, he was afraid they might lose the money. Mr. Lively made motion and Mr. Lopez seconded the motion in favor of Lou Morgan Builders bid and it was approved 3-0.

Mr. Skaggs also spoke on behalf of the fire departments. Mr. Skaggs stated of conflict with fire co-ordinator and fire chief. Mr. Skaggs stated the co-ordinator should not be chief of the fire department. The fire departments submitted the name of Steve Cruikshanks, to be hired as co-ordinator.

Mr. Skaggs also made comment on the Fire Levy Funds. He stated that the departments are having financial situations. Mr. Skaggs ask for money to be given so the departments could operate through January and February. The Commission approved the amount of \$2,500.00 for each department. Mr. Lively made motion and Mr. Lopez seconded the motion. The motion was approved 3-0.

Mr. Bragg told the Commission that Mr. Gannon and Mr. Joyce would like to see the landfill hauling limited to once or twice a week to individuals. The Commission decided to leave landfill hauling as it is now

The Fayette County Commission met in regular session on December 5, 1984. The Commission received two resumes in response to the County Co-ordinator job for the Fire Departments. Resumes received from Johnny R. McComas and Chris Martin.

The Commission received a letter from the City of Montgomery. The letter stated that the request received from the Fayette County Commission had been voted on and approved at the Solid Waste Authority Board Meeting.

- 1. The first Wednesday of every month has been designated for Fayette County Citizens as the day when they can bring household type trash and garbage to the Montgomery Landfill and dump free of charge. (When this goes into effect it will be advertised in the Montgomery Herald.)
- 2. If it becomes necessary for the commission to place a transfer station in this county which would need to be dumped at the Montgomery Landfill, the Solid Waste Authority will be more than willing to negotiate terms.

This letter was received from the office of James F. Higgins, Jr. Mayor. Appearing before the Commission was Myles Harrington, representing Russell, Rea & Zappela, Inc., Investment Bankers, with Inducement Resolution concerning bonds for hospitals. The inducement would be for Hospital Improvement and Equipment Acquisition Revenue Bonds. Mr. Vickers ask why the county would want to participate. Mr. Lively questioned why no one from Montgomery Hospital was present for the meeting. Mr. Vickers thanked Mr. Harrington for appearing before the Commission and stated that at a future meeting they would act upon this presentation. Mr. Vickers stated if Montgomery General was interested they should contact the Commission.

Appearing before the Commission was Gladys Gray of the Senior Citizens
Program. Mr. Lou Morgan of Lou Morgan Builders appeared with Ms. Gray and presented a bid on work to be done for remodeling on building for the Senior Citizens.

The bid was for the amount of \$89,400.00. This consist of remodeling kitchen and dining room for the nutrition center. This bid is to include all labor and materials to complete all work on remodeling of the Senior Citizen Center in Oak Hill. The Committee on Aging will meet with Ms. Gray on December 6, 1984, concerning the plans.

Mr. Lacy A. Flint appeared before the Commission in regards to application a for a job that he filed with the Commission for janitorial work. Mr. Flint told the Commission he had been out of work for some time and that he had filed application before and had no response from it. He wondered if he could be considered for the next job opening in janitorial service.

Appearing before the Commission was a representative from Summersville RSVP - Region 4. Ms. Evelyn O'Dell and Pastor McCutcheon. The area of Region 4 is headed by Mr. Larry Bradford. Ms. O'Dell and Mr. McCutcheon appeared before the Commission asking for a contribution of \$1,500.00 from Commission stating they will ask each county for a contribution. The Commission approved this action 3-0.

Appearing before the Commission was Mr. Erwin Conrad, Lawyer and Mr. Vince Evans, representing Steptoe & Johnson for Issuance of Industrial Development of Revenue Bonds. The delegation made presentation to the commission and then the Commission heard pro and con of the issue. Citizens of the Boomer area who opposed expressed opposition. Mr. Harold Lewis Coe, Pastor, of the Boomer Baptist Church presented a resolution unanimously passed by the members on December 2, 1984. The Boomer Baptist Church requested that the Commission deny permission of the Fayette Dock Corporation to set up a coal loading dock at the old Exxon Bulk Plant site located next to the Boomer Baptist Church in Boomer, West Virginia. The resolution stated that they feel such a truck-in coal loading dock would be very bad for Boomer and disasterous for the Church in particular, for the following reasons:

- 1. The extreme danger of turning off Route 60 into the road to the loading site. This is in a large dip and stopping and turning is already dangerous.
- 2. Because of the dirt and coal that would come off the vehicles as they exit Route 60 on the only entrance going by our church and to their site as it passes our church.
- 3. Because we have a Kindergarten through Twelfth grade School that would be hindered by noise as trucks would have to pass within 15 feet of classrooms (our school is from 8:00 A. M. -3:00 P. M.)

Beginning on January 2, 1985, the landfill will be closed on Sundays.

The Commission informed Mr. Bragg to go ahead and get final plans on the IBM computor system for the county.

Names were submitted for the Fayette County Correctional Officers Civil Service Committee. The Committee to have regular member from the Bar Association. Names submitted for the Committee as follows:

Roy Withrow, Judson Wallace, Athol Burgess, Carolyn Paul. Action will be taken at a later date.

Mr. Lopez, Commissioner discussed the possibility of contribution to the Kanawha Falls Public Service District. Mr. Joe Craffey is to obtain document and final bid and verification of matching fund by Local Public Service District. This will be taken up at a later date.

The Commissioners received a letter from Montgomery Chamber of Commerce, Upper Kanawha Valley, Economic Summit Conference, December 19, 1984, at West Virginia Institute of Technology, Tech Center Ballroom.

The Commission ask Mr. Bragg to contact Don Start, Architect, referring to magistrate building and the prosecutor building. The Commission wants to look at plans for \*wo buildings. This is to be estimates for the job.

The Commission decided not to hold a meeting on December 26, 1984. All bills and payroll will be approved on the 14th of December, 1984.

A letter was received from Circuit Clerk, Herbert A. Mann, in regard to the change in his office. Catherine Britt moved to North Carolina and Mr. Mann stated the changes in his office and salaries he wished his employees to receive. He also ask for Linda Myers to be added to his staff.

There being no further bussiness to come before the Commission the meeting was adjourned.
